2. **Entry Period.** The Sweepstakes begins on or about 12:00:01 a.m. CST on September 7, 2009, and ends at 11:59:59 p.m. CST on September 10, 2009 ("Entry Period").

Then, comment on one of the blog posts with a link to your social network/blog post. Limit one entry per person regardless of method used to enter. No purchase necessary. Entries must be postmarked (or, if by online means, submitted) no later than the last day of the Entry Period and must be received by the time of the drawing to be eligible for the drawing. Duplicate entries from the same person in excess of one (1) will be automatically disqualified.
4. **Winner Selection/Prize(s).** To select the winner, there will be one (1) drawing at the Sponsor's headquarters in Nashville, Tennessee, on September 10, 2009, conducted as follows: On or shortly after noon on the date of the drawing, one (1) winner will be chosen in a random drawing from among all eligible entries received by Sponsor by the time of the drawing, to receive the Prize.
